AFFILIATE SPLIT

Under this "insurance-based" model, revenue is primarily driven by setup and monthly fees rather than the specific services provided.

It functions as a volume business: fees collected from clients who do not use the services offset the revenue lost by providing discounted representation to those who do.

While the monthly fee is fixed, the Affiliate may negotiate the setup fee with each client.

AFFILIATE WILL RECEIVE 75% OF THE SET-UP FEE.*

Claw backs will be limited by a non-refundable policy (i.e., except for extraordinary circumstances).

Affiliate payment is a marketing fee, and not a revenue share (as required by law)

MAKING THE SALE

The Defender Plan is ideal for clients that do not want the full law firm representation, are under a debt settlement program, have imminent collection lawsuits on the horizon and closing in, or simply have financial struggles and are getting behind on credit card payments.

Like insuring a car, they'll have the protection and peace of mind needed for personal debt, the number one stressor in life. All for a small monthly cost (unlike car insurance).

Being free from harassment and having attorney representation in court are guaranteed rights under the law in every state.

As an affiliate, this is a small add-on to any pitch given to a prospect. You will already have gone through their financial struggles, and looming threats. Increase your production and revenue with a simple pitch.

COLLECTOR HARASSMENT (FDCPA violations)

When harassing calls or any collector communication happens, the client contacts us. We will send out letters communicating that we represent the client and all further communication must go through us. A cease and desist notice is given, and any further calls are potentially a violation of federal and/or state law. We will review any collector communication and if they are actionable we will begin the litigation process.

Successful actions often result in a waiver of debt, deletion of the tradeline (credit report entry), and statutory awards of \$500 to \$1000 that go directly to you.

IDENTITY THEFT

If your identity is stolen, and debts are taken in your name, you should not be responsible. We will review your case and if actionable, we will begin the litigation process.

Successful actions can result in removing false information, removal of the debt, and damage awards. Referral to criminal prosecution may also occur.

SUMMONS DEFENSE (Collection suits)

Generally, a creditor will pursue a court action against you as early as 3 months past due on a credit card, but generally in the 6 to 24 month range. The creditor will seek the full balance of your debt, plus interest, attorney fees, court fees, and any other awards they can get.

For a small monthly fee we will provide immediate notice to the creditor that we represent the client, and they must communicate solely with us. We will take proactive measures to resolve this suit as quickly as possible, appear in court as needed, and ensure the courts are properly notified.

Please note, as creditors will begin collection calls prior to filing suit, it is important that the client reports any collection harassment, as this can provide a counter suit and resolution in the clients favor.

CLASS ACTION INCLUSION

Specializing in debt collection and reporting violations, as well as summons defense, means we will have opportunities for class action suits as well. If we begin such a suit, we will notify the client for a review of their case and eligibility for inclusion in the class action.

Expected results are debt waiver, tradeline (credit report) deletion, and monetary award.

TAX RESOLUTION

The IRS and state taxing authorities are serious about collecting the money they are owed. They employ an enormous staff, including prosecuting attorneys in every state. Should a client have any tax debts, they will need experienced representation to resolve the issues. We provide a no-cost referral to Milestone Tax Solutions. And, as our direct referral, the client will receive a discount on fees. We do not receive any compensation for the referral and pass those savings on to the client.
